Please Note: The EAPASA Office will close on 21 December 2021 and reopen on 05 January 2022.




# **EAP Registration Statistics**



EAPASA has 477 registered EAPs and 66 Candidate EAPs to date. Please note that the Section 24H of the National Environmental Management Act (NEMA) states, "No person other than a registered Environmental Assessment Practitioner, may hold primary responsibility for the planning, management, coordination or review of environmental impact assessments and associated EMPrs."

We encourage all Environmental Practitioners to submit their applications before the statutory deadline of 08 February 2022.



#### **Reminder: CPD Submission**



EAPASA is required to ensure that registered members undertake Continuing Professional Development (CPD).

To meet this SAQA requirement, registered EAPs are reminded to undertake, record and save a Portfolio of Evidence (PoE) of their CPD activities.

EAPs are requested to keep an 'EAPASA CPD Record Sheet', to be submitted annually, with the next submission due in February 2022.

# EAP REGISTRATION STATUTORY DEADLINE: 08 FEBRUARY 2022

# PLEASE NOTE THAT YOU HAVE 53 DAYS LEFT TO MEET THE LEGISLATIVE REQUIREMENT TO BE A REGISTERED OR CANDIDATE EAP

Please Bear in Mind that - the 120-day Section 24H assessment process commences once:

- The Registrar has deemed your submitted application to be complete, and
- 2. Proof of payment of your registration assessment fee has been received.

#### Please note:

- You are strongly advised to submit your application as soon as possible to ensure your application is evaluated before 08 February 2022.
- Non-registered EAPs will not be allowed to carry primary responsibility of EIAs after 08 February 2022.
