## FORM OF PROXY

The appointment of a proxy may also suspend at any time and to the extent that the Registered member who appointed such proxy chooses to act directly and in person in the exercise of any rights as a Registered member.

A proxy shall be in line with the wishes of a member as contained in the proxy form.
