### **IAIA Climate Change Symposium**



26 - 28 September 2022 | Cape Town, Western Cape

Celsius 1.5: Impact Assessment and Climate Change

EAPASA will be hosting a panel discussion at the upcoming IAIA Climate Change Symposium taking place in Cape Town from 26 – 28 September 2022. The panel will consist of representatives from the Department of Forestry, Fisheries and the Environment (DFFE), South African Council for Natural Scientific Professions (SACNASP), Council for the Built Environment (CBE) and International Association for Impact Assessment South African affiliate (IAIAsa).

The panel will discuss the role that is played by the Environmental Assessment Practitioners Association of South Africa (EAPASA) in collaboration with other institutions in support of the climate change mitigation and adaptation agenda.

The negative impacts of climate change are more prevalent today and South Africa is already embarking on a journey of transitioning to a climate resilient economy and decarbonisation which will bring about several positive changes.

These changes are expected to follow a sustainable development path, principles of Just-Transition guided by anticipation, adaptation and recovery from a changing climate and environment.

The role of an EAP has therefore become more significant as these professionals are at the forefront of development projects and proposals.

#### **CPD SUBMISSION**



EAPASA would like to thank all EAPs who have managed to accumulate CPD credits thus far. For those lagging behind with the CPD credits, please make sure to catch up now or in the next cycle.

All Registered EAPs are required to undertake, record and provide a portfolio of evidence of CPD activities as a prerequisite for renewal of their professional registration for each (5) five-year period of registration.

The responsibility to meet the CPD obligation rests with the registered professional who must ensure ongoing learning. EAPs can earn CPD points by attending accredited events or by completing online courses.

#### **EAPs Involvement in Environmental Justice**



Environmental justice refers to "fair treatment and meaningful involvement of all people, regardless of race, colour, nationality, or income group, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies."

EAPASA, as a Registration Authority, aims to improve the quality of environmental assessment practice in South Africa by acting against improper professional conduct and malpractice by Registered EAPs.

All Registered EAPs have a responsibility to adhere to the Code of Ethical Conduct and Practice found in the EAPASA Rule Book. EAPs are expected to carry out their professional activities in compliance with relevant environmental legislation and, as far as reasonable and practically possible, in accordance with the principles of sustainable development.

Due to different interest groups, the use and exploitation of our natural resources often produce conflicts or differences. EAPs should see to it that the integrity of the environment, including conservation and long-term sustainable use of the biophysical environment, and the social welfare, health and safety aspects of the socio-economic environment, are upheld above any commitment to sectional or private interests.

Environmental justice allows the environment to be treated with caution and accountability to protect its resources.



# EAP Registration Statistics & Compulsory Registrations



To date, EAPASA has registered, **714** registered EAPs and **171** Candidate EAPs. Environmental professionals should bear in mind that EAP registration is now mandatory and only registered members may hold primary responsibility for the planning, management, coordination or review of environmental impact assessments and the associated Environmental Management Programme Reports (EMPRs).

Unregistered Government Officials and Private Consultants are encouraged to fast track their applications to avoid engaging in fraudulent or illegal practices.

Unregistered EAPs are also prohibited from making use of the Reg. EAP (EAPASA) or Cand. EAP (EAPASA) on their email signature. Furthermore, unregistered EAPs should refrain from using the term Environmental Practitioner since this title can only be allocated by EAPASA through their professional registration body status by SAQA.

All applicants are reminded to make use of the correct URL <a href="https://registration.eapasa.org/">https://registration.eapasa.org/</a> to log into the online registration system.

The EAPASA office staff is there to assist with any queries. For those who are struggling to complete different sections of their applications, they may request previous presentations and recordings from the office.
