EAPASA Regional Conference, 28 - 30 Nov 2022



EAPASA hosted a successful Regional Conference last year in Mookgophong, Limpopo Province. The organisation extends its gratitude to the 130 delegates for their positive attendance.

The conference dealt with topics such as the alignment of Integrated Environmental Management and harmonisation of the EIA process in the SADC region, the role of Registration Authorities in improving IEM practice in Africa, and the application of adaptation, mitigation measures and early warning systems when faced with catastrophic natural disasters such as floods and droughts in Africa. We thank our local South African EAPs who attended the conference and continue to support EAPASA.

Delegates had an opportunity to engage with other relevant role players operating within the Environmental sector in Africa. EIA for Infrastructure Projects Conference, 12 Oct 2022



EAPASA attended and hosted a panel discussion at the 1st Annual EIA for Infrastructure Projects Conference, which was held at the Indaba Hotel, Johannesburg on the 12 October 2022.

The topic of the panel discussion was "The role of Environmental Assessment Practitioners in Infrastructure Projects EIAs, EAPASA's Perspective" which was presented by the Board Chairperson Ms Snowy Makhudu, Public Relations Chairperson, Ms Jacqui Hex and the Registrar Dr Patrick Sithole.

The history of EAPASA, positioning of organisational structure, function, and operations of organisation were imparted during discussion. The conference was а success. reinforcing connections between the environmental assessment and civil engineering sectors, which often work hand-in-hand in developing infrastructure nationally and reiterated the significance of interdisciplinarity in the professional space.

EAPASA CPD SUBMISSION



EAPs are kindly requested to record CPD credits guided by the three (3) categories described in the CPD guideline document. The EAPASA CPD Categories and Record Sheet can be downloaded on the EAPASA website.

Evidence must be attached to the CPD Record Sheets and be submitted to cpd@eapasa.org.

Important: EAPs that are behind with their CPD submission are reminded to catch up as soon as possible. It is the responsibility of an EAP to ensure that at the end of 5-year period, all 25 CPD credits have been acquired. Supporting documents must be submitted.

Misconduct of EAPs



All Registered EAPs and Candidate EAPs are reminded to adhere to the EAPASA Code of Ethical Conduct and Practice.

Complaints against EAPs are being lodged with the Registrar and EAPASA is obliged to enforce a code of conduct regulating the ethical and professional conduct of registered members.

Unethical EAPs must note that the organisation will take any reasonable steps necessary for the protection of the public and the environment.

EAPASA can only act against Registered EAPs and Candidate EAPs. Complaints received against non-registered persons are referred to the relevant environmental Competent Authority and / or the South African Police Services for investigation.

All charged EAPs, their contraventions and penalties may be advertised on the EAPASA website for a period not exceeding 5 years which will be in line with their registration cycles.
