The recommended professional consultation fees are listed in Schedule I below.

EAPASA is a legally constituted entity and a registration authority appointed by the Department of Forestry, Fisheries and the Environment (DFFE) under Section 24H of the National Environmental Management Act, Act No. 107 of 1998 (NEMA as amended) and the Section 24H Registration Authority Regulations as the single registration authority for professional Environmental Assessment Practitioners (EAPs) in South Africa. EAPASA is also recognised by the South African Qualifications Authority (SAQA) as a Statutory Professional Body in terms of the National Qualifications Framework Act, Act No. 67 of 2008 (NQF as amended).

SCHEDULE I

Definitions

In this Schedule the definitions are as follows:

“Registered Candidate Environmental Assessment Practitioner (Candidate.EAP)” means a Candidate Environmental Assessment Practitioner who is registered as such by the registration authority (EAPASA) appointed in terms of section 24H of the NEMA in accordance with criteria prescribed in the Section 24H Registration Authority Regulations, 2016 as amended.

“Registered Environmental Assessment Practitioner (Reg.EAP)” means a an Environmental Assessment Practitioner who is registered as such by the registration authority (EAPASA) appointed in terms of section 24H of the NEMA in accordance with criteria prescribed in the Section 24H Registration Authority Regulations, 2016 as amended.
