EAPASA APPROVED EQUIVALENT QUALIFICATIONS

In terms of Subregulation 15(1)(a)(ii), registration can be done using the Equivalent Qualifications criteria. The Equivalent Qualification is aligned with EAPASA's SAQA Qualification Standard ID: 61831. EAPASA recently conducted a study that analyzed and compared all environmental qualifications/programs offered at the higher learning institutions in South Africa. Applicants that have obtained these qualifications can be registered using the Equivalent Qualification registration process.
